Approval of Minutes

Rental Car Signage

Report on Fair Fares Online Survey Conducted by WSU

Steve Flesher presented a summary of the Fair Fares survey that was conducted by the Center for Economic Development and Business Research at WSU. The survey was recommended by the Wichita Area Outlook Team as a community service project. The Fair Fares resident survey is part one of the overall study; part two will focus on the economic impact associated with Fair Fares. Discussion ensued. The Fair Fares program will end in October and at that time it is hoped that area companies will partner with AirTran and Frontier.

WAAB Volunteer for an Airport Advertising Consultant Selection Panel

Bell stated that the contract for the Ditch the Drive advertising campaign expired the end of June. There has been consensus that this advertising program should continue. However, it is necessary for the City to solicit proposals from advertising agencies to continue advertising for six to twelve months to promote the low fare carriers. Boully volunteered to participate on the consultant selection panel.

Master Plan/Terminal Area Planning Project - Status Report

Staff is still waiting for funding from the FAA.

April/May 2003 Statistical/Project Report

In April, total passengers increased 12.86% over 2002; in May, total passengers increased 3.96% over 2002.
